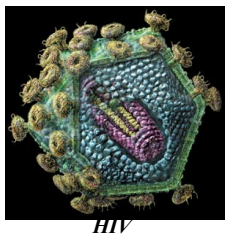


BACKGROUND



HIV/AIDS infection among drug users issue is need serious

handling. Up to May 2004, HIV/AIDS cases among drug users in Bali reported 250 cases, most coming from productive age groups 20 to 39 years old.

Other data which show the problems level are mortality effect of complicated various disease, one of AIDS issues, more than 30 drug users in Denpasar and Kuta in range of less than 4 years (interview with key person of former Injecting Drug Users). Most of victims have never experienced HIV test and medical treatment. Most of

this numbers not included in number reported by Health Department of Bali Province yet.

Besides, illegally drugs usage has generated another social issue. More than 32% drugs users confess have experienced into institution or prison that effected of drugs usage or criminal related to drugs usage. Some of drugs users have experienced of collision punish although do not experience litigation (interview with key person of former Injecting Drug Users).

Other problem that faced is lack of facility which can assist them to break a habit of drugs

usage. Even so they succeed to desist, possibility to relapse still in high level. For example craving which often emerge if drugs users do not have activity, peer pressure, lack of support to keep maintaining their clean and sober. Besides, because most of drugs users trying to use illegal drugs in young age, hence mean all drugs users have low education level and do not have skilled which can support them to look for work.

Level of issues that mentioned above, is needing to address with existence of comprehensive program, which is pre-emptive program to depress the amount of newborn

drugs users, supply reduction program is to reduce illegal drugs supply which can be accessed by illegally drugs users, demand reduction program to assist those who have willing to total abstinence from drugs usage, including also after care program to assist

them maintain their clean and sober, and harm reduction program to reduce risk of HIV/AIDS infection and other health issues of drugs usage.

Yayasan Matahati is a non-government organization who founded by a group of former drug users and supported by activists of harm reduction at July 19th

2004 as response to the issues. Yayasan Matahati has program focus on drugs, HIV and AIDS prevention in Bali.

Our mission is to reduce harm in social aspect, economics and health as consequences of illegally drugs usage that based on community programs in Bali

Yayasan Matahati cope to give comprehensive service, which cover:
(1) Harm reduction Program related to drugs usage impact to reduce risk of HIV/AIDS infection and another health issues, including Pre-Emptive program to prevent illegally drugs

usage; (2) Recovery Program to reduce request of illegal drugs; (3) Care, Support, and Treatment Program (CST) for them who infected by HIV/AIDS; and also (4) After Care Program to assist them which have desisted to use drugs, so they can continue life hereinafter and return to society life without using drugs .

Entirety of this program will be run interconnected and continually with each formed division and supporting one another.

Implementation of program activity will entangle peer group support and NGOs and other relevant institution to

guarantee fluency and efficacy program .



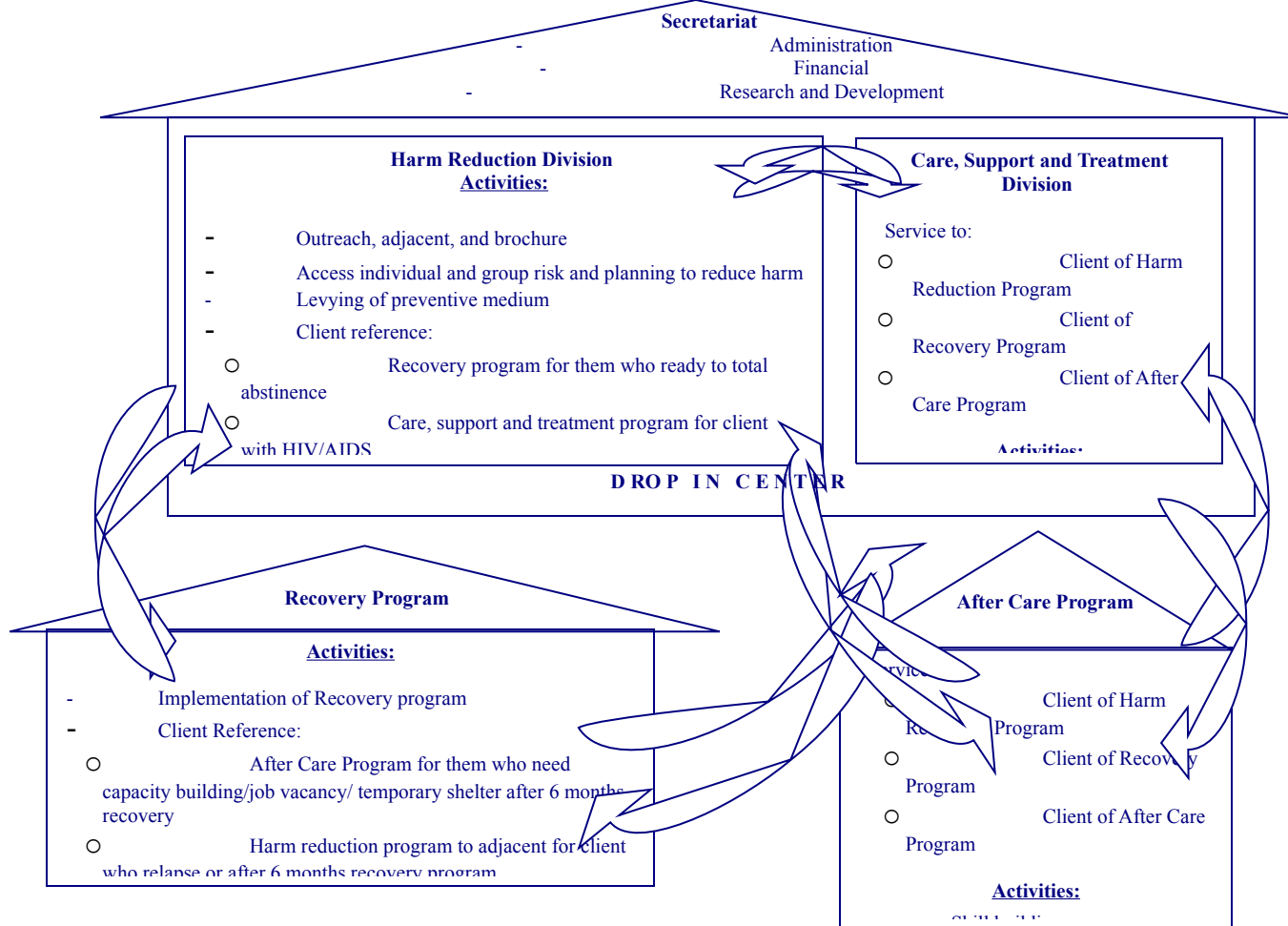
